As per Memorandum of Agreement (MOA) signed on February 21, 2011 with the Professional Regulatory Board of Medicine known as the "BOARD" wherein the pertinent resolution states that "THE BOARD DEPUTIZES THE PHILIPPINE MEDICAL ASSOCIATION, INC. (PMA) THRU ITS CONTINUING MEDICAL EDUCATION COMMITTEE (CPE/CMECOMMISSION) TO EFFECTIVELY CARRY OUT PROFESSIONAL REGULATION COMMISSION Resolution No.2008-466 AND OTHER RESOLUTIONS RELATED TO CONTINUING PROFESSIONAL EDUCATION".


Anent this, we would like to inform you that all CME Activities will not be given CME Units until the organization requesting has been endorsed by the Philippine Medical Association as APPROVED as CPE Provider by the Professional Regulations Commission.

The PMA -CME Commission is requiring all Medical Related Organizations to apply as CPE Provider on or October 31, 2011 in order to be accredited by the PRC. Requirements/ forms will be available at the PMA-CME Commission Secretariat.
