The PMA: Breaking ground and going beyond its walls

The Philippine Medical Association is a proactive organization that does not only work for the welfare of physicians, but also, and perhaps more importantly, is concerned with the health, well-being and productivity of the populace and society as a whole. True to this calling, PMA has engaged with a number of relevant agencies, through the leadership of incumbent President. Dr. Ireneo C. Bernardo III. It has to make its voice heard and its advocacies raised to a wider audience.

Over the past few months, the following is a sampling of the work that has been done.

With the Department of Health:

The President participated in the Alliance on Patient Safety National Convention last December 2, 2016. This was conducted by the Health Facilities Development Bureau of the DOH and held at the First Pacific Leadership Academy in Antipolo.

January 18, 2017 was a fitting start to the year as the meeting regarding foreign medical missions transpired with the Secretary of Health presiding.

Another very important gathering was held last May 8, 2017. This was the 2nd Consultative Meeting on the Revision of the 2007 Skills List of Health/Medical professions. Held at the iHealth Conference Room of the DOH Compound, this workshop reviewed the fields of specialization in the health and

medical professions in accordance with the existing needs of the country.

With the Philippine Health Insurance Corporation (PhilHealth):

The PMA President attends regularly the meetings which are held practically on a monthly basis. This is all about accreditation.

With the Professional Regulations Commission:

Dr. Bernardo was invited as speaker on the subject "How can the medical profession be valued in the International Market Global Value Change". This was held on June 27, 2016. Still, the bulk of the interaction with PRC concerns Continuing Professional Development, the PMA President being a prominent member of the CPD Council. Meetings are held on a regular basis.

With the Association of Philippine Medical Colleges:

November 22, 2016 was the schedule of the Conference "Primary Care Experience in Basic Medical Education: Impact on a Physician's Career Choice". This was in celebration of the 50th Anniversary of the APMC, held at the Ateneo Professional Schools Auditorium, Rockwell, Makati.

Moreover, last February 2, 2017, Dr. Bernardo received the Award of Recognition for PMA given by APMC during the Golden Anniversary Dinner held at Novotel Hotel, Cubao QC. This

was followed on February 3 with a talk by Dr. Bernardo at the Medical Students Network held at the Ateneo School of Medicine and Public Health.

Other activities in International Events:

The PMA President was the Official Delegate at the World Medical Association last October 19-22, 2016 at Grand Hyatt Taipei, Taiwan. He also participated at a similar convention of the WMA, "One Global Health Conference". November 10-11, 2016, this time held at Fukuoka, Japan and hosted by the Japan Medical Association. The most recent conference attended by Dr. Bernardo was the MASEAN Conference at Park Royal Hotel, Kuala Lumpur, Malaysia, April 25-27, 2017.

Meanwhile, on the local front, the PMA President continues to collaborate with counterparts within the network. Last May 5, 2017, he graced the Opening Ceremonies of the Philippine College of Surgeons Midyear Convention at Limketkai Luxe Hotel. On May 7, it was the turn of the Philippine College of Physicians for its Convocation and Awards Ceremony at SMX Convention Center.

May 6 saw the President act as the Guest of Honor, upon the invitation of Makati Medical Society, to its 55th Emerald Foundation Day, Dr. Jose L. Mathay Memorial Lecture and Most Outstanding Physician Awarding Ceremony, at the City Garden Grand Hotel, Makati.

"The Problems of Health Programming"

The Philippine Health Agenda 2016 -2022 which launched the Healthy Philippines 2022, enumerated the three goals, values, three guarantees and seven strategies to pursue the health for all objective of government. To bolster the attainment of the plan designed by the technocrats in government, the budget allocated for health under the present administration was raised to provide more services under the National Health Insurance Program.

During my provincial and regional sorties throughout the archipelago, I have repeatedly mentioned and emphasized the fact that the full range of "health" encompasses the entire spectrum of the promotion of health status, the prevention or control communicable and non-communicable diseases, the restoration of lost health or the cure of illness, and the rehabilitation of the disabled, ill or infirmed back to usefulness to himself and to society. However, in health care programming, services have been generally classified into programs for disease prevention and those for curative health. This conventional division, strictly speaking, is a misnomer. It is because there really is no intellectual disagreement over the theory that the cure of a disease in one individual patient helps prevent its occurrence in others, while a timely attendance given to any diseased condition tends to lessen the need for a more extensive curative care thereof later. This is a truism that is uncontestable. Moreover, there hardly is any aspect of clinical medicine in this day and age that is without is preventive component as well. The only difference between the preventive and curative services lies in the need to seek what health measures are considered the most effective and efficient system of health care delivery to adopt and implement in the least cost way possible. This now becomes the central issue raised by those who believe that "integration" is the right answer as oppose to the concept that both prevention and cure each requires specialization, and should be allowed to develop separately.

The theories relied upon by those who support the concept of integration find too little expression in the real health service delivery. The separation of the preventive from the curative health care, even when placed under one and the same administrative authority tended to persist acutely apart as ever. Why was this so? This is due to human nature itself, because when a particular human behavior is nurtured through centuries of practice, the same cannot just be altered nor put aside by merely effecting change in its operational environment. The existing professional values and personal preferences which have been deeply embedded.

in the minds of those concerned will resist change whether by legal compulsion or by the use of administrative power. This is what a physician, who learns to specialize in one field will feel and be expected to do. His professional attitude will remain to perpetuate the figment of functional differentiation that prevailed between the function of disease prevention and their cure or treatment. This being the case, some learn to accept the situation as they are and allow them to develop their respective lines accordingly.

Concerning the current health programs of the government, it may be conceded that there is always an honest effort to develop them with well meaning goals which are aimed to solve perceived health problems or to improve our country's health condition. It is hard, however, to imagine health programs could be developed when relevant health data are not available or that the health information presented were not data that can be complete nor sufficient for a dependable assessment of the true health picture of our population. Program objectives under this situation cannot be accurately identified nor defined and therefore the determination of their resource requirements is not possible.

One big problem in health care programming is the limitation of available resources that makes their allocation to the various health programs a very subiective decision process, rather than otherwise. The government is usually left without much choice but to go ahead with health programs believed convenient to pursue although they have very little contribution to the attainment of the goals and values of the Philippine Health Agenda 2022. Programs are sometimes developed on the government's assumptions and quantitative analysis so that those perceived to provide the most benefits usually get the most in-puts and given priority consideration. Under conditions of uncertainty and time pressure, health programs are pushed through if they at least appear academically sound. In some instances, funds are distributed in proportion to the speculated improvement in the health status. What would be a bad scenario is when more funds are given to programs thought of having the greatest capability of building the image of those in political and administrative control....



"Message of the PMA President during The Night of Leaders"

Last March 22, 2017, the first Night of Leaders was launched at the Bayanihan Complex of the United laboratories Inc. with the Hon DOH Secretary Paulyn Jean Rosell-Ubial as guest of honor and keynote speaker. More than one hundred allied health organizations were invited including friends from media and the legislature.

The organizers of the event adopted the theme entitled: "Collaboration Towards Global Health" with representatives from the medical profession, nursing profession, dental practitioners and pharmacy group giving the preliminary talk after the welcome message of the PMA President, Irineo C. Bernardo III, M.D. delivering the welcome message and the objectives of the event. Below is the excerpt of that message:

After greeting the dignitaries and thanking United laboratories for accommodating the Philippine Medical Association in hosting the affair, Dr. Bernardo started by reciting the preamble of the World Health Education (WHO): "The highest attainable

standard of health is one of the fundamental rights of every human being, without distinction of race religion, political belief, economic or social conditions."

"Yet, the highest attainable standard of health has not been realized by the majority of our people up to this point in time. The huge disparities in health that exist among our people remain one of the great moral and intellectual problems of our time.

In the health care delivery system, the end-point goal is what really matters. All activities made in preparation to pursue our national health objectives or goals, no matter how elaborately executed, will be a waste of time, effort and resources if at the end-point the health care needs of our people are not met.

The greatest danger is to confuse "fat" with "activity". It is here at the end point that we , in the health sector, should ask whether or not there are sufficient resources in both manpower and logistics that are readily available to satisfy the demand for care. In fact, this is the service criterion , the performance standard , that must govern the provision of health care and by which we, in the health sector, must comply with religiously.

There are three GOALS mentioned by the Duterte Administration to wit:

 Ensure the best health outcomes for all, without socio-economic, ethnic, gender and geographic disparities;

Let us continue to collaborate and commit to achieve excellence in delivering healthcare services to our nation.

- Promote health and deliver health care through means that respect, value and empower clients and patients as they interact with the healing system;







As Philhealth always emphasize that it is our privilege to be a Philhealth provider, however this privilege can be removed from us if we violate their rules and regulations.

Most common reasons of Denial of renewal of some of our members: ghost patients, failure to pay the necessary payment on time and fake or altered certificate of good standing. Last January, Philhealth NCR issued a memorandum that each member of PMA should acquire original certificate of good standing. As of now, more than 2000 original with PMA seal COG were issued for free.

Last April, Philhealth spearheaded a consultative meeting with its stakeholders and the specialty division representatives regarding the division of professional fee among the attending physicians. This is in preparation with the separation of the professional fees from the hospital bills of the patient. Another meeting will be done before the release of the final circular.

All processing of renewal of our PRC ID are now online. Starting July, CPD units will be needed in order to acquire your new updated PRC card.

MMDA

New UVVRP Guideline: Doctors on-Call to show PRC ID to be Exempted

The Metropolitan Manila Development Authority announce last March 30, 2017 that Physicians and medical doctors responding to emergency cases need not apply for an exemption from the unified vehicular volume reduction program or the number coding scheme.

According to MMDA, medical practitioners in an emergency only need to show their updated PRC (Professional Regulation Commission) identification cards in case they will be flagged down by traffic enforcers for UVVRP violation.

MMDA General Manager Tim Orbos said this new guideline shows that the agency recognizes the necessity of unhampered travel for medical doctors responding to emergencies.

"We are optimistic that this new rule will not be abused by doctors and that they will be conscientious in using this privilege" Orbos said.

PMA Ambulance

For several years, the ambulance is not being utilized. The outgoing BOG approved of its renovation and together with equipment and emergency medicine. During the concluded PMA convention the PMA ambulance is in the vicinity of the Manila Hotel.

Greetings from the Central Tagalog Regional Council!

The Central Tagalog Regions met several times, formulated opinions, and the same was submitted to the Board of Governors of PMA the council collated and escalated down to its members the different policies and notices from the PMA for implementation.

Among the proposals of the Central tagalong Region includes but not limited to the following:

- 1. Empowerment of the Component Society. The date of receipt of membership dues from the Component Society must be receipt of the PMA thus attaining membership in Good Standing. There shall be a 15% rebate of membership dues for the different projects of the Component Societies. The clamor for inclusion of the different activities such as the medical missions be included in the CPD units of the members had been subsumed by the CPD rules as mandated by RA 10192. Empowerment of the Component Society to handle the first level of Medical Ethics cases is now incorporated in the new Code of Medical Ethics for the Medical Profession subject to its implementing rules and regulations.
- 2. Amendment of the Medical Act of 1959.

The Central Tagalog region recommends the reduction of the Pre Med Courses for 2 years. With the implementation of the K-12 curriculum with several stem/trucks of 2 years in the

science courses, the two year course with Associate in Arts is sufficient for entry to the College of Medicine. The details of this were submitted to the Board of Governors. These included granting of the Bachelor's degree after a 2 vear Medicine proper. In the event the student cannot proceed to the Medical Course he can qualify for work or pursue a Masters/ Doctorate Degree. The standard of Medical curriculum remains the same as the Medical Act of 1959 as further amended. Other revisions of the Medical Act need to be revisited.

- The present state of proxy votes in the Amendments of the PMA Constitution and By-Laws is highly improbable. There is further need to re-study the same documents and incorporate the following suggestions but not limited to it.
 - a. Clear Declaration of physicians' right to practice his profession.
 - b. Conversion of PMA into a true corporate structure and function. Further to study the effect in the event of Federalization of the Republic.
 - c. Incorporate the Implementation of RA 10192 in the bylaws.
 - d. Address the ASEAN mutual recognition agreement.
 - e. Clear the exclusivity of the practice of Specialization and Sub specialization and the need to address the needs of other areas such as the rural and far flung areas. Details are with the secretariat and Board of Governors.
- 4. The implementation of the recommendation of the Commission on Audit and the internal Auditor, Villaruz, Villaruz and Co. CPA's. Several violations were found in the financial statement of 2015-2016. The commission of Audit

and Internal Auditor of cited several violations and made several recommendations. Further, there must be accountability of the personnel who violated the Rules of Procedures of the Manual on Audit. There must be accountability of the PMA Officers who caused and/or exercise supervision and control over these personnel.

Herewith are some of the activities of the different Component Societies of the Region:

Caloocan City Medical Society Annual Report 2016-2017:

The Caloocan City Medical Society had a very active, productive and organized year of activities which started even before the fiscal year officially started. The President, Dr. Marie Lucille Aguilar-Aniciete, organized immediately a fundraising project to fund the activities of the society.

The board meetings were held almost every month. Training/seminars for emergency awareness and preparedness were conducted in two barangays. Community outreach through feeding programs, deworming programs, and social activities were held in the communities which were participated by officers and members of the society. Some of these Medical missions were conducted in cooperation with several Agencies. Seminars and round table discussions were also held almost monthly. The CCMS also collaborated with the MCU Department of Pediatrics for a Post-graduate course for doctors, nurses and midwives.

The CCMS was also active during the Medicine Week. There was a free clinic at the PMA Auditorium. PINK RIBBON PROJECT Dr Aileen Hidalgo, FPCP Oncologist

Breast cancer is the second most common cancer in the world (next to lung), and accounts for the most number of female malignancies. It ranks as the 5th cause of death from cancer overall, but is the most frequent cause of cancer-related deaths in women in less developed countries, with the Philippines not excluded from this gloomy data. It is very disheartening to see very active women of different age groups succumbing to this type of cancer, more often in advanced stages of the disease when nothing or very limited can be done to save their lives. The Philippine Medical Association - Zamboanga del Sur Chapter is cognizant of the above problem. It is noted that lack of information, awareness, and understanding of the disease are the main culprits why breast cancer is not detected early. Even the very simple monthly breast examination is not being done. Also, the "fear" of cancer drives women not to seek early consultation but, instead, go to "quack doctors" who promise instant relief with the murky potions that they dispense. Thus, information drive is deemed crucial in the fight against breast cancer.

Faced with this daunting task, the Zamboanga del Sur Medical Society launched the Pink Ribbon Project, which commenced four years ago in partnership with the Philippine Society of Medical Oncology (PSMO). All Barangay Health Workers (BHW) of Pagadian City, in cooperation with the City Health Office, were invited to a seminar on breast cancer awareness. They were taught how to detect early signs of breast cancer and do simple breast examination. They were taught how to detect early signs of breast cancer and do simple breast examination. Information leaflets on breast cancer awareness were given by the PSMO as part of reading materials in the barangay clinics.

We informed the local government units that doctors are available to conduct lectures/seminars on government employees about cancer in general, and breast cancer in particular. We also partnered with the allied medical services (mainly pharmacists) in bringing information drives to areas where medical missions are conducted. The media was also utilized to bring cancer awareness to a wider audience. TV and radio guesting was done when invited by the media to talk about cancer. The biggest project accomplished so far was with the Cancer Support Group of Pagadian City, together with the Zamboanga City Cancer Support Group and ICanServe Foundation, when women from all walk of society gathered together to support Breast Cancer Awareness month last October 22, 2016. Groups from different government offices and barangays gathered together to do zumba, attended lectures and submitted themselves to breast examination.

We are very much aware that we are just dealing with the tip of the iceberg. More has to be done to make a significant leap from cancer detection to prevention. But we are going in the right direction, and we are hoping for more support for our cancer warriors.

Marawi City and Lanao del Sur Province has a total population of approximately 1 million. It has different hospital catering the people around lake Lanao. Mainly there are 5 district hospitals, 4 primary hospitals and the Amai PAkpak Medical Center which is a 300 bed capacity DOH-retaining institution, located in the heart of Marawi City. In these hospitals are doctors ranging from general practitioners to specialists and sub-specialists.

The word 'MAPIA' means Good/Pleasant in Maranao dialect. Thus, this association is very timely since the PMA believes that it shoud have a harmonious relationship with the drug companies. The main purpose of creating this association is to provide security and safety to the visiting medical representatives. This is spearheaded by the LDSMS President Dr. Mohammad Al-Mogtader A. Abedin, the PNP Chief Juliani Asadil and the City Mayor Atty Majul U. Gandamra.

Last Feb. 2, 2017, The MAPIA was officially inaugurated at the Marawi Resort Hotel in MSU. Marawi City. The following set of officers were inducted: President Aliah D. Lao. Commission on Legislation

Updates on the proposed bill for the new Philippine Medical Act (or Physicians' Act).

Congressman de Vera of ABS Parylist thru the initiative of Congresswoman Eriguel is sponsoring the bill on Physician's Act (Philippine Medical Act). Copies of the same were provided to House of Representatives Committee on Health Chairperson Angelina Tan as well as to Congresswoman Vilma Santos Recto, Senators Richard Gordon, Antonio Trillanes IV, and Francisco Pangilinan. Emails have also been sent to Senators Grace Poe, Chiz Escudero, Manny Pacquiao, Aquilino Pimentel, Jr., Loren

Legarda, Cynthia Villar, Migz Zubiri and Risa Hontiveros Baraquel. Further, Congresswoman Michaela Meneses Antonio of Agbiag Partylist has already filed the bill on Philippine Medical Association Integration.

In addition, the 10% tax imposed on sugary beverages has already passed in the Lower House of Congress. When finally approved, such will minimize consumption of beverages, which contribute to the increasing incidence of diabetes, hypertension and obesity in our country. Hopefully, the funds that will be raised from this tax will be used to augment the budget of the Department of Health and/or of Philhealth.

CME COMMISSION

The PMA CME/CPD commission was assigned to chair the Scientific session of the 110th PMA Annual Convention. After several months of brain storming in the presence of my commissioners and representative of the specialty and affiliate societies, we agreed in the different topics namely:

- 1. "Are sleep disorders: An epidemic"
- 2. "Caffeine: A silent hazard"
- 3. "Drug Addiction: A chronic multi system disorder"
- 4. "Food supplement: Is there a clinical benefit?
- 5. "Metabolic Syndrome: From Womb to Tomb"

The format of the presentation is a Panel discussion spearheaded by a moderator who will present a case as a jumping board for the discussion. Anytime during the discussion questions from the floor can be entertained by the moderator.

The Theme of Our Scientific Session is "One Topic different view points towards' one Goal.

"Isang Paksa Sari Saring Pananaw Patungo sa Isang Layunin"

To further acquaint you of the selected topics let me show you the objective of the different session.

SESSION #1 "Are Sleep Disorders: An Epidemic"

Caffeine is a chemical that acts as a stimulant. It is most commonly found in tea, coffee and cacao plants. This natural stimulant is one of the most commonly used ingredients in the world. Each day, millions of people turn on caffeine for energy and boost, to increase wakefulness, reduce fatigue, and improve concentration and focus. Around the amount of caffeine in four cups of brewed coffee, 10 cans of cola or two "energy shot" drinks or up to 400 milligrams (mg) of caffeine a day appears to be safe for most healthy adults. There are conflicting reports on the health effects of caffeine. This session examines the latest research on caffeine and its impact on health, both beneficial and adverse.

SESSION III A "Food Supplement: Is there a clinical benefit"

Dietary Supplements

A dietary supplement is a product intended for ingestion that contains а "dietary ingredient" intended to add further nutritional value to (supplement) the diet. A" dietary ingredient" may be one, or any combination, of the following substances: a vitamin, mineral, herb or other botanical, amino acid, concentrate, metabolite, constituent, extract or a dietary substance for use by people to supplement the diet by increasing the total dietary intake. Dietary supplements may be found in many forms such as tablets, capsules, softgels, gelcaps, liquids, or powders. Some supplements can help assure that you get enough of the vital substances the body needs to function; others may help reduce the risk of disease. A dietary supplement is "not represented as a conventional food or a sole item of a meal or the diet" or to replace complete meals which are necessary for a healthful diet. Unlike drugs, supplements are not intended to treat, diagnose, prevent, or cure

diseases. That means supplements should not make claims, such as "reduces pain" or "treats heart disease." Claims like these can only legitimately be made for drugs, not dietary supplements. Dietary supplements can be beneficial to your health – but taking supplements can also involve health risks. This session aims to further explore scientific evidence for or against the use of dietary supplements.

SESSION III B " Drug Addiction: A chronic Multi-System Disorder"

General objective: To discuss addition as a multisystem disorder Specific objectives:

- To describe the stages in developing drug addiction, from initiation of drug use to harmful use, and discuss the possible etiologies
- 2. To discuss the neuro adaptive changes that underlie the transition from harmful drug use to a stage of drug dependence
- 3. To discuss the acute and chronic effects of drugs on the cardio-vascular system and describe related pathological findings
- 4. To describe the harmful sexual behavior associated with drug use and discuss the effects of drugs on reproductive health.

SESSION IV" Metabolic Syndrome: From Womb to Tomb"

Objectives:

- By the end of the discussion, the audience would have confidently diagnose Metabolic Syndrome
- 2. By the end of the discussion, the audience are adept in the diagnostic work ups of people suspected of MS
- By the end of the discussion, the audience can confidently manage people with MS

- By the end of the discussion, the audience had been equipped to stop CVD and Diabetes which are dreaded consequences of MS

May I also inform the membership of the tasks of our commission.

PMA CPD COMMISSION

As approved in the last PMA Governor's meeting last January 14 in Silang Cavite, the PMA CME Commission will also be known as "PMA Continuing Professional Development Commission" and will perform the same function.

As per Republic Act No. 8981 and Resolution No. 2013-774 we will be following the one hour lecture for every 1 CPD credit unit. All CPD credit units will emanate from the PMA CPD Commission and/or PRC CPD Council.

As per Republic Act 10912 also known as the "CPD ACT of 2016", all CPD providers should apply to PRC for accreditation. All accredited CPD providers should fulfill all necessary requirements prior to approval 45 days before their said activities. All specialty societies can apply as CPD providers. For specialty societies they can still have their own CPD requirements for CGS but will need to adopt the 1 hour 1 lecture policy.

All component societies need not apply as independent CPD providers since PMA is already an accredited provider. They will however need to issue a CERTIFICATE OF ATTENDANCE for each CPD activity that

they will conduct duly signed by the Component President, Secretary and CME Coordinator.

For proper monitoring, all specialty societies, affiliate societies and component societies, will need to submit the attendance of all CPD activity to the secretariat of PMA who will then make a summary of every member's CPD attendance which can be used for the renewal of PRC licenses and for the PQF purpose. Likewise we will be also using our OWL@PMA for monitoring and on-line learning. Once the PMA RFID card are done for encoding we will be using them for additional monitoring of CPD activities.

CPD Programs consist of activities that range from structured to non-structured activities, which have learning processes and outcomes.


