Greetings!

Please be informed that the deadline for the submission of the Membership Listing will be on September 10, 2014. The PMA Membership Staff will still have to encode all of the membership lists submitted by all component societies. We are fast tracking this so that PMA can come out with an accurate voters list. After September 30, 2014 the membership staff will have to encode the lists of member who paid their dues on the last day, to enable the submission of the voter's list by the PMA National Comelec on the November 8, 2014, Board meeting of the Board of Governors for approval. These approved lists will be disseminated by the National Comelec by November 15, 2014.

All Component Societies may check their voters list and may petition the PMA National Comelec for **Exclusion** or **Inclusion** of any of their members not later than December 30, 2014. The submission of the membership listing will continue and will be accepted by the PMA. However, the PMA Membership Committee will have to submit to the National Comelec the **current** list of good standing members in PMA data base, until we have the corrected one from your Society. Please complete all data so that PMA may have an accurate data base.
