Greetings!


In corollary to Memorandum Circular No. 2014-10-01-018 issued last October 01, 2014, regarding the Membership Discount on Arrears (Balik PMA Program), we are pleased to announce that the PMA will be granting as an incentive, a 10 percent rebate on the arrears due to the PMA, collected during the 6 months period of the program from **October 1, 2014 to March 31, 2015** by all component medical societies. This move is to encourage all component medical societies to exercise their best efforts in the collection of all arrears and thus bring all inactive members back into the PMA fold as active members.

The rebates shall be paid in full by the PMA after the 6 months period of the program to the component medical society.


As a reminder, this program is for all PMA members with arrears from 2013 and earlier, wherein the PMA grants a 50 % discount. However, the annual dues for 2014-2015 should be paid in full. All component medical societies are enjoined to grant the same discount with thier local dues.
