RESOLUTION NO. 101

WHEREAS, Republic Act No. 10767 directs the Department of Health to prepare a Philippine plan of action to eliminate Tuberculosis;

WHEREAS, the Department of Health has issued Executive Order No. 187 or the Comprehensive and Unified Policy for TB Control in the Philippines;

WHEREAS, the said policy will be implemented by the National Coordinating Committee of the Department of Health

WHEREAS, the Department of Health has recognized the Philippine Medical Association (PMA) as one of its main partners in enforcing the above policy on TB Control;

WHEREAS, one of the members of the National Coordinating Committee will be the President of the PMA or his or her duly authorized representative

NOW, THEREFORE, the Board of Governors Resolves that the Philippine Medical Association shall:

Strongly support the policy mandated by Republic Act No. 10767 for the elimination of Tuberculosis in the Philippines.

Cooperate with the Department of Health in conducting programs aimed at preventing, diagnosing, treating and controlling Tuberculosis.

Cooperate with the Department of Health in conducting an information campaign on the policy of eliminating Tuberculosis and to issue advisories to PMA members about the requirement of reporting with immediate dispatch cases of Tuberculosis.

Cooperate with the Department of Health in the conduct of basic and clinical research of Tuberculosis in the Philippines
