SUBJECT: PAYMENT OF PMA ANNUAL DUES

DATE : OCTOBER 19, 2020

This is to re-iterate that Accounting section will only receive PMA annual dues coming from the PMA Component Societies, as discussed and affirmed at the 3rd monthly Board Meeting on October 10, 2020 (Board Resolution No. 084 Series 2020).

Pertinent documents on the matter:

BY-LAWS:

Article I, Section 1: "The members of the Association shall be physicians duly licensed to practice medicine in the Philippines and whose names have been entered into the roster of members of the Association. Membership in the Association shall be through a Component Medical Society of the Association."

Article III, Section 1: ..."The manner of collection of membership and other dues are stipulated in the Administrative Code of the Association."

ADMINISTRATIVE CODE:

Chapter II, No. 2: A regular member of the PMA shall be deemed inactive of he fails to pay the membership annual dues of P1,500.00 (as of the date of approval of this Code, of P1,500.00), to the **Treasurer of the Component Society** of which he is a member, not

later than the last day of September of each administrative year, which amount does not include Component Society dues.

Accordingly, payment of annual dues to the PMA National Office will only be accepted through the local Component Society, as approved by the Board of Governors
