## MEMORANDUM CIRCULAR NO: 2024-11-12-027

To : **Presidents and Treasurers of the PMA Component Societies**  
From : **PMA Committee on Membership Services and Development**  
Subject : **Voter's List: Petition for Inclusion / Exclusion & Transfer of Voters**  
Date : **November 12, 2024**

Attached is a copy of the approved Voters' List of your society for the March 9, 2025 (Sunday, 8:00 AM – 5:00 PM) Online National Elections to be used as your reference in reviewing the records of your members for possible inclusion/exclusion of names in the list.

Please be reminded of the provision in the Election Code with regards to the transfer of voters to wit:

“Article 2 Section 5. Transfer of Voter. A member may transfer membership to another Component Medical Society, as provided for in Article 1, Section 4 of the By-Laws. During the current administrative year in which the transfer is processed, approved and effected, the voting right of the member shall be exercised in the previous Component Medical Society where the member is originally listed in the Official Voters list. In the year following the transfer, the member shall then be included in the Official Voters list and shall vote in the Component Medical Society into which he transferred. “The corresponding changes in the Official Voters list of the Component Medical Society shall be accomplished by the Membership Committee and the Secretary-General.”

The deadline for the submission of the petition for inclusion/exclusion in the voters' list is on December 30, 2024 as stated in Article 2, Sec. 4 of the Election Code...

Preparation of the Official Voters List. The PMA Membership Committee and the Secretary General shall prepare the Official Voters List of every Component Medical Society and shall present the same to the Board of Governors for approval not later than November 15 of the current administrative year. Once approved by the Board of Governors, the Official Voters List shall be sent to the Presidents and Treasurers of the Component Medical Societies, not later than November 30 of the current administrative year.

Upon receipt of the Official Voters List by the Component Medical Society, the President and Treasurer shall verify and validate the individual status of the members
