MEMORANDUM CIRCULAR NO: 2024-10-14-030

SUBJECT : DUES REINSTATEMENT PROGRAM 2024-2025

DATE : October 14, 2024

The PMA Board of Governors 2024-2025 in its first (5th) Regular Board Meeting last October 12, 2024 approved the **DUES REINSTATEMENT PROGRAM 2024-2025**, Resolution No. 049 Series 2024-2025.

The **PMA Dues Reinstatement Program** is a structured **arrears payment scheme** designed to assist members in settling their outstanding PMA dues. Under this program:

- Arrears Payment Plan:** Members can clear their arrears within a three-year period.
- Current Dues Requirement:** To qualify, a member have at least 5 years unpaid dues and must pay their two current dues in full.
- Program Duration:** The program will be available for seven months, running from **November 1, 2024**, to **May 30, 2025**.
- However, if the member has only one (1) year arrear or back due (covering fiscal year 2023-2024) he/she is **not** entitled to payment scheme and has to pay the arrears/back dues **in FULL** (Php1,500.00) plus payment for the current fiscal year 2024-2025 membership dues of Php1,500.00.
- Likewise, members with arrears of four (4) years or less are **not** entitled to the said program and has to pay the arrears back dues **in FULL** plus payment for the current fiscal year 2024 – 2025 membership dues of Php1,500.00.

The usual requirements in availing the following benefits will apply as:

- PMA Mutual Aid Benefits – Death, Disability and Legal Benefits**
- Within the 1st to 4th year of enrollment, no benefits (2024-2028)
- Within the 5th year of enrollment, 25% (2028-2029)

This benefit will be granted, provided that the member continuously pays his/her membership dues yearly and remain in good standing, incurring no arrears or back dues again.

D. Right to vote and be voted upon. Suspended for the fiscal years (2024-2028) following the reinstatement. The member is entitled to vote in the next fiscal year 2028–2029 (PMA Election 2029) provided that he/she pays the dues on or before September 30, 2028.

The right to be voted upon shall be restored only after having been a member in good standing for at least five (5) consecutive years immediately preceding the election.

E. Eligibility for Life membership.

To be eligible for the Life membership, a member needs to have a continuous, uninterrupted payment of dues for the (10) years from the year of reinstatement (2024-2025). May be eligible for Life membership on (2033-2034) and pay the necessary one-time due for life membership.

F. Eligibility for Emeritus Membership.

To be eligible for emeritus membership, a member who is 65 years old at the time of application to have continuous, uninterrupted payment of dues for 15 years from the year of reinstatement (2024-2025). May be eligible for Emeritus membership on 2038-2039 provided he continues to be in good standing after reinstatement.

We request everyone to disseminate this program especially to those with long standing arrears and inactive members so they can avail of this opportunity and come back to PMA and become member in good standing.

I understand that I can avail of amnesty or similar special program only once throughout my PMA membership. I declare that I have not availed of amnesty before. I understand that the **DUES REINSTATEMENT PROGRAM 2024-2025** is given by PMA in good faith as an opportunity for me to return to active membership status. In applying for this, I will **pay in full** the membership dues for the **last two fiscal years 2023-2024 & 2024-2025**. My remaining arrears from fiscal year 2022-2023 and earlier will be paid in installments over a period of three years. However, if I have only less than two (2) years arrears or back dues (from fiscal year 2022-2023 and earlier) I am **not** entitled to the reinstatement program and have to pay my arrears/back dues **in FULL** plus payment for the current fiscal year 2024-2025 membership dues of Php1,500.00.

The usual requirements in availing the following benefits will apply as:

A. PMA Mutual Aid Benefits – Death, Disability and Legal Benefits

B. Within the 1st to 4th year of enrollment, no benefits (2024-2028)

C. Within the 5th year of enrollment, 25% (2028-2029)

This benefit will be granted, provided that the member continuously pays his/her membership dues yearly and remain in good standing, incurring no arrears or back dues again.

D. **Right to vote and be voted upon.** Suspended for the fiscal years (2024-2028) following the reinstatement. The member is entitled to vote in the next fiscal year 2028–2029 (PMA Election 2029) provided that he/she pays the dues on or before September 30, 2028.

The right to be voted upon shall be restored only after having been a member in good standing for at least five (5) consecutive years immediately preceding the election.

E. Eligibility for Life membership.

To be eligible for the Life membership, a member needs to have a continuous, uninterrupted payment of dues for the (10) years from the year of reinstatement (2024-2025). May be eligible for Life membership on (2033-2034) and pay the necessary one-time due for life membership.

F. Eligibility for Emeritus Membership.

To be eligible for emeritus membership, a member who is 65 years old at the time of application to have continuous, uninterrupted payment of dues for 15 years from the year of reinstatement (2024-2025). May be eligible for Emeritus membership on 2038-2039 provided he continues to be in good standing after reinstatement.

After enrolling in the Dues Reinstatement Program, I pledge to settle my remaining balance in three annual installments, ensure the timely payment of future annual dues, and uphold my status as a responsible member in good standing.
