MEMORANDUM CIRCULAR NO: 2026-07-06-07

To : All PMA Component Society Presidents and Treasurers
Subject : Timely Payment of PMA and Component Society Annual Dues
Date : July 6, 2026

In line with the start of the new PMA Fiscal Year (June 1, 2026 – May 31, 2027), may we request your assistance in reminding and encouraging all members of your respective Component Societies to settle their PMA and Component Society Annual Dues at the earliest opportunity.

Please be guided by the following:

1. The PMA Fiscal Year begins on June 1 and ends on May 31 of the succeeding year.
2. A member who pays the PMA Annual Dues within the current fiscal year is considered an Active Member of the PMA.
3. To enjoy the full benefits and privileges of PMA membership, a member must also be a Member in Good Standing, which requires payment of both the PMA Annual Dues and the corresponding Component Society Annual Dues for the current fiscal year.

Timely payment ensures continued eligibility for benefits under the Mutual Aid Fund (Death, Disability, and Legal Aid), the Calamity Assistance Fund, and the issuance of a Certificate of Good Standing (COGS).

Please likewise remind your members that payment of annual dues on or before September 30 is required to qualify to vote and be voted upon in the PMA National Elections.

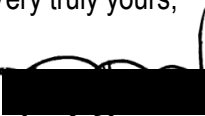
Finally, upon the request of the PMA Accounting Department, all payments for both PMA and Component Society Annual Dues should, whenever possible, be coursed through the respective Component Societies to facilitate efficient processing, proper documentation, reconciliation of records, and prompt issuance of official receipts.

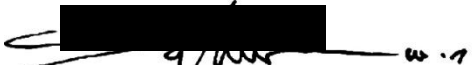
