Please provide detailed information addressing the following criteria:

1. Length of Service in the Philippines - 10 points
Reflects the physician's dedication to the people, the trust developed within the community, and the physician's continued involvement in addressing the health and welfare needs of the population.
2. Professional Development: Professional Excellence - 10 points
Refers to the physician's demonstrated competence, achievement, leadership, innovation, and overall excellence in the practice of medicine and in the delivery of healthcare services.
3. Health Program Established/Maintained - 35 points
Recognizes the physician's significant contribution to improving the health and well-being of the community through the establishment, implementation, maintenance, leadership, or improvement of health programs.
4. Humanitarian Service - 30 points
Recognizes the physician's service to humanity beyond the direct practice of medicine. A physician demonstrates compassion and service through efforts that address the social, economic, educational, humanitarian, and developmental needs of individuals and communities.
5. Awards and Recognition - 15 points
Recognizes the physician's achievements and contributions that have been acknowledged by reputable institutions, organizations, professional bodies, government agencies, or other recognized entities.

NOMINATION BOOK GUIDELINES

Submission of the Award Book

The Award Book shall be submitted in two (2) copies, prepared in accordance with the prescribed 20-page Nomination Book Guidelines.

The Award Book shall present a clear, organized, and concise documentation of the nominee’s accomplishments, contributions, and qualifications relevant to the criteria for The Outstanding Filipino Physician (TOFP).

The submission of the Award Book serves not merely as a requirement for evaluation but also as a comprehensive presentation that enables the Board of Judges to fully appreciate the breadth, depth, significance, and impact of the nominee’s professional, community, health, humanitarian, and other contributions.

All entries shall strictly follow the prescribed 20-page format and guidelines. Supporting documents and evidence may be included as annexes or attachments, as may be allowed under the official submission guidelines.

Two (2) copies of the completed Nomination Book shall be submitted within the prescribed period.
